# 1. Introduction

Our website, <u>https://www.natgeokids.com</u> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). # 2. What are cookies?

# 3. What are scripts?

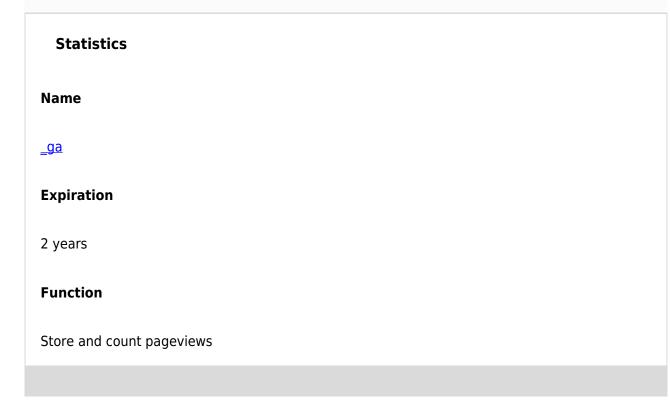
